## Request for Information – Local Government Official Information and Meetings Act 1987

We refer to your email request dated 18 November about money owed to ratepayers by Hutt City Council.

Your request has been processed according to the provisions of the Local Government Official Information and Meetings Act 1987 (the "Act").

Your request for information has been granted, and Council's response to your questions is as follows:

"Please provide the gross amount of money owed to ratepayers by Hutt City Council as the result of overpayment or overcharging overall and also analysed by the following age groupings 0-3 months 3-6 months 6-12 months 1-2 years 2-5 years 5-10 years 10 years+"

No money is owed to ratepayers for overcharging.

"Please also specifically split out rates overpayments and also provide the average amount owed for each of the categories requested."

Currently there is approximately \$68,000 overpaid by 96 ratepayers, these are all current 3 to 6 months. The value per property ranges from \$10,000 to \$15. We contact any overpayments and offer to refund but more than often they like to have a credit stay on their account for future rates.
