Request for Information – Local Government Official Information and Meetings Act 1987

We refer to your official information request dated 27th February 2020 regarding changes to rubbish collection.

Please find the information you have requested below.

- Waste Management NZ personnel attended three meetings in direct relation to the kerbside review. The first one was a one-hour meeting in August, to provide an overview of the kerbside review process; the second meeting was a Logic Mapping Workshop (whole-day) at the end of 2019 in order to identify problems with the current service model. The outcomes of the Logic Mapping workshop are available as part of the business case, available in Appendix 2 of the business case at http://iportal.huttcity.govt.nz/Record/ReadOnly?Tab=3&Uri=5498208. Waste Management NZ personnel were also present at a workshop in early 2019 where Morrison Low presented the long-list of options. Short-listing of options took place after that.
- Bruce Sherlock (Contracts Manager Solid Waste) and Jörn Scherzer (Manager Sustainability and Resilience) met with Ray Lambert from Low Cost Bins, on 4 April 2019, in Paraparaumu Beach. The meeting involved a discussion on the kerbside review, the options being considered, and a quick look at Low Cost Bins' operation in Paraparaumu. There are no minutes from this meeting.
- In terms of information provided to Councillors on this consultation, the only direct information on this was provided to Councillors on 26 February 2020, in response to a question from Councillor Milne about any contact officers has had with two businesses: Low Cost Bins and Al's Litta Binz.
