### Request for Information – Local Government Official Information and Meetings Act 1987

We refer to your official information request dated 8 July 2020 for information regarding Subdivision stats.

The information you have requested is enclosed.

The information attached should be sufficient to make any necessary calculations at your end. Unfortunately our software that contains all of this information works by pulling information of event sequences and associated dates so it is not as kind for interpretation. If you require anything else then just let us know and we can do what we can to assist. I have broken down the two spreadsheets below with a description of the information displayed.

The attached spreadsheet relates to granted subdivision consents received between June 2019 and July 2020. I hope it is easy to interpret and should be sufficient to work out any mean and median days as per your request. The information in this spreadsheet is directly pulled from our applications management system. The days are described above each column which contains separate information for days associated with s37 extensions or limited notified submission periods; days on hold (such as via s92 requests); statutory days exclusive of any additional days. The final column for days is total days irrespective of if it was on hold or otherwise.

In terms of the number of applications lodged between June 2019 and July 2020 (since not all of these would be granted at this time for various reasons) we received 24 subdivision consents and 88 subdivision and land use combined consents between this period.

We don't track the days specifically for each 223/224 application however what we have done is pulled the information relating to what date a 223/4 application was made and the date it was issued – noting that there may have been some back and forth regarding information etc.

In terms of the attached 223/224 information I will give a bit of a breakdown of what the categories cover/mean. It should be noted that the spreadsheet includes entries for each event (i.e. when something is received and when something is issued or approved) so there will be up to two entries per consent in column A. With reference to your request the primary areas for the 223/4 information are in columns I (Event Decision Description) and J (Event Date). Respectively these identify what event was answered and when —as an example RMI50009 below has two entries in the spreadsheet (rows 3 and 4) the first is when the 223 was received and the second is when the 223 was approved each with their own date that this took place — the difference between these dates can be used to work out the number of days (as noted above our system does not track this directly).
