Request for Information – Local Government Official Information and Meetings Act 1987

We refer to your official information request dated 7 February 2021 for information regarding the funding for the Southern Section of the Beltway. The information you have requested is enclosed.

- a) Whether HCC currently has funding in the budget to complete the Southern Section of The Beltway.
 - o HCC currently have no funding committed to completing the Southern Section of The Beltway.
- b) if not, whether funding for the Southern Section is included within the scope of the Micromobility SSBC and;
 - o Funding for the Southern Section is not included in the work programme recommended by the Micromobility SSBC.
- c) if not, whether HCC is planning a separate funding approach for the Southern Section.
 - o A separate funding approach will be required for the Southern Section at some stage in future but we currently have no plans for this.

Further, your comment that funding for the Southern Section is not addressed by the Micromobility SSBC but is included in the funding committed/completed diagram in that report is correct and will be corrected as this document moves from draft to final form. There is obviously an intention to construct the Southern Section of The Beltway when funding and competing priorities allow, but at this stage no funding has been committed.
