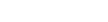

Dear Mayor & Deputy Mayor

At last week's mayor/ce catch up you requested that I consider the current CPC43 application and whether it was feasible/sensible to proceed with this in its current form or pause and wrap it up into a wider district plan review. Seperately, Deputy Mayor wanted advice around his own ability to participate in cpc43discussion/decision (preferred) in view of acknowledged objections to cpc43 from Mrs Bassett and Mr B junior. I have asked for an opinion on the second point – this note covers the first issue.

What I hadn't appreciated when we spoke last week was that the cpc43 haring is taking place next week on 2-5 September, with a hearing decision anticipated late October for consideration by full council in November. So it would be extremely late in the day to make this decision, particularly when over\$1million NZD expenditure has been incurred to date.

Helen Oram has very helpfully compiled a list of benefits / problems with adopting a different approach and this is set out below. I'm also conscious that cpc43 has so far been determined by full council, and any change now would

require a decision of full council, which makes any change of approach now practically impossible as well as, I would suggest, inadvisable. Happy to discuss at our catch up tomorrow, and thought this would be useful in advance.

Hi Jo

Here are my thoughts around Plan Change 43 – carrying on or withdrawing and incorporating into a full District Plan review.

I have tried to be completely objective about the matter.

Benefit of withdrawing the Plan Change & incorporating into the full District Plan review:

- Diffuses opposition in the short term
- We will be seen to responding to a certain sector of the community
- Defers the issue to a later date and look at the issues around housing intensification with new eyes

Keep going with the Plan Change:

- The Plan Change is looking to help free up land for intensification if it is approved, it has the potential to help with the housing crisis, and complement our homelessness work.
- National Policy Statement on Urban Development Capacity directs Council's to create sufficient capacity for
 development expected in the short, medium and long term (3, 10 and 30 years) in its District Plans. That is,
 in three years we must have a certain amount of land available as ready to build on (meaning zoned, and
 serviced) this Plan Change if it gets approved, will help to release land so that we have sufficient
 capacity, and will help to comply with the National Policy Statement. We wouldn't be able to comply if we
 left this Plan Change until the review of the entire District Plan.

Note: The government is looking to change this National Policy Statement (and the new one is out for consultation currently, but it will build on, rather than remove this requirement).

- There has been engagement with the community over Plan Change 43 over several years, including most recently correspondence around the hearing, a Friends of Submitters service we set up to talk to our community, etc. I believe it would be very confusing for people if this long process was suddenly stopped.
- The whole process for this plan change has cost us in the order of \$1m+ this money would be completely wasted if we cancelled the plan change and incorporated it into the District Plan review process because we would need to start again with all the experts reports, etc (they would be too old to use again).
- The Plan Change proposes to introduce a medium density design guide, which we currently don't have. This guide is designed to encourage good design. Without this in place, the planners are concerned, with the current development pressures, there will be piecemeal design across the city.

Background:

The purpose of the proposed plan change is to increase Lower Hutt's housing capacity and provide a wider range of options for housing styles/sizes at medium densities in the urban area.

This could include low-rise apartments and terraced houses in areas that have good access to public transport, shopping, parks and schools, but also minor additional dwellings (this is what used to be called "granny flats" – I can't remember the UK terminology) on smaller sites that don't have the potential for traditional infill – this will help to allow people to add a tiny house to rent/house their parents or teenagers!!

The Plan Change reviews the rules in the "normal" residential zone, called the *General Residential Activity Area* and proposes the introduction of two new zones:

- medium density residential development and
- suburban mixed use in targeted areas.

The plan change also proposes introducing a new Medium Density Design Guide.

There are nine targeted areas for the new zones, being Stokes Valley, Taita, Naenae, Avalon/Park Avenue, Epuni, Waterloo, Alicetown, Waiwhetu/Woburn and Wainuiomata.

There are about 20 people who have asked to be heard in relation to the Plan Change Hearing (there were around 260 submissions).

Key dates:

- Plan Change hearing: 2-5 September 2019
- A hearing decision is required by late October
- Council will meet to discuss the panel's decision in November
- Hearings on the submissions start on 2 September for three days.
- There are 30 working days to lodge appeals to the Environment Court on the decision.
