Request for Information – Local Government Official Information and Meetings Act 1987

We refer to your official information request dated 9 April 2020 for information regarding closing the Wainuiomata Trail Park to cyclists.

A new order made under the Health Act does not allow any kind of recreation that may expose a person to danger and may require the intervention of the emergency services.

The basis for closing is not related to recorded number of injuries. Mountain biking is an inherently risky sport and, Council isn't always made aware of injuries occurring on its sites. Moreover, the decision is related to Council being cognisant of Ministry of Health guidelines and messaging around exercising within your bubble and locally without traveling, but more importantly and you've touched on this, this facility may require emergency service intervention because of the risky activity.

We will monitor and review the use of our facilities, and may have to close them if our people aren't able to use them responsibly, in line with the Government's advice.
