We refer to your official information request dated 28 May 2021.

Your request:

"I have heard from multiple sources that you may have requested from council entities information on what, if any, commercial dealings they have had with Riverside Media, a company owned by Councillor Leigh Sutton and the degree of such dealings. I am sure that this would not be the case as it would be highly unusual for a CEO of a council to make such enquiries.

Could you please: Send me, via email, any correspondence between or on behalf of yourself relating to Riverside Media and any other person; or If there has been no such correspondence then confirmation to that effect from you would be sufficient."

>> I was unaware of a Council regulation which precluded Seaview Marina Ltd from advertising in a magazine owned by a Councillor. Could you direct me to the relevant Council policy as I will add it to our policy file.

>> In this instance Leigh Sutton approached me, Michael Mead (Compass Café) and Robert Baldock (Shipwreck Traders) with the proposal we promote our facilities in the Vibrant Hutt. The cost of \$600 was shared equally between the three businesses. This is the third or fourth time, over the last seventeen years I've been running the marina, I have advertised in the magazine. While the marina does very little by way of print media advertising I agreed to the article as the Vibrant Hutt reaches a market Seaview Marina is targeting, it has a focus on the Hutt and it is a quality magazine.

>> Now I am aware of the Council's policy I will not advertise again with Vibrant Hutt and I'll make sure the new Chief Executive is made aware of this ban.
