Request for Information - Local Government Official Information and Meetings Act 1987

We refer to your official information request dated 24 June 2020 for information regarding listed buildings at Epuni School.

The information you have requested is below.

The buildings at Epuni School, are identified as heritage buildings in the District Plan, but not in the New Zealand Heritage List (which can be found at https://www.heritage.org.nz/the-list).

The buildings at Epuni School (313 – 319 Waiwhetu Road) are identified in Appendix Heritage 2 of the District Plan as heritage buildings. Appendix Heritage 2 identifies buildings that have not been identified as heritage buildings in the New Zealand Heritage List (maintained by Heritage New Zealand Pouhere Taonga), but have been identified by Hutt City Council as making a notable contribution to local heritage.

As the buildings are identified in the District Plan as heritage buildings, there are specific policies and rules in the District Plan that apply to activities that may impact the buildings, including alterations and maintenance to the buildings. These rules may require resource consent for alteration and maintenance of the buildings, or other activities that may impact the heritage values of the buildings.
