Request for Information - Local Government Official Information and Meetings Act 1987

We refer to your official information request dated 2 December 2020 for information regarding Bridge inspection regimes. Please see our responses below.

- The frequency (in years) of general bridge inspections within your jurisdiction
 - Every two years.
- 2. The level of liaison between the inspectors and the contractors who carry out the recommended remedial work?
 - a) what does this consist of e.g. written, verbal, joint site inspection
 - HCC's Consulting Engineers undertake the bridge inspections and provide the Management, Surveillance and Quality Assurance (MSQA) for any resulting bridge maintenance work contracts. This includes verbal and written instruction, site visits and surveillance, and undertaking quality assurance regimes.
 - The Parks department engage a separate engineer to oversee some of the maintenance where the bridge is in a poor condition and is also subject to budget considerations
- The frequency of principal bridge inspections (in years)
 - Every 5 years.
- What is the trigger for principal bridge inspection?
 - The 5 year frequency regime. Additional special inspections are undertaken if there is an significant event that warrants an additional inspection, or if significant damage or deterioration is identified through a general inspection or other means.
- Is the principal inspection completed by the same engineers who undertake the general bridge inspection?

- HCC's Consulting Engineers undertake all general and principal inspections.
- 6. What document storage facilities are used to track actions arising from the bridge inspection and engineer's recommendations
 - HCC's electronic document and record management system TRIM.
- 7. Do the inspections follow the guidelines published by NZTA?
 - Yes, inspections are undertaken in accordance with NZTA's Bridge Manual and Inspection Policy.
