Request for Information – Local Government Official Information and Meetings Act 1987

We refer to your official information request dated 18 November for information regarding figures relating to menacing and dangerous dogs.

The information you have requested is below. However we have decided to refuse part of your request under section 17 (f) of the LGOIMA that the information requested cannot be made available without substantial collation or research.

- 1. I would like to know the number of dogs council believes there are in this area, broken down by registered and unregistered (if the latter is held in any form). I'd also like to know how many of these dogs are classified as dangerous or menacing.
 - Dangerous Classification 27 total 3 unregistered this year
 - Menacing Classification 196 total 17 unregistered this year
- 2. Of the menacing or dangerous dogs, how many received the classification due to their breed, and how many received it due to an incident?
 - Breed 111
 - Incident 112
- 3. Can I please have the number of dog incidents/attacks reported over the past five years, broken down by year, type of incident, whether there were injuries and if those injuries were to another animal or a person, and whether the incidents involved a dog that had already been classified as menacing or dangerous.
 - Unfortunately our system does not break information down in as detailed a manner as you are requesting and cannot be made available without substantial collation or research. Please find a table of dog incidents/attacks reported over the past five years, broken down by year and type of incident.

 - Yes dogs are only classified if the criteria fits
- 5. How many of these incidents involved a dog that was previously classified as dangerous or menacing, but the owner had been non-compliant with restrictions?
 - Our system does not record this information and cannot be made available without substantial collation or research
- 6. Of the dogs in this area that have received a classification due to an incident, rather than due to their breed, what breeds are they?
 - Please see the attached "All breeds currently classified due to deed.xlsx" document
- 7. How many challenges have been made to a menacing/dangerous dog classification over the past five years, broken down by year, and whether the challenge was successful or not?
 - There have been 2 objections (challenges) that went to a hearing and they were both upheld
- 8. Can I please be provided with details of the process and criteria for classifying a dog as dangerous or menacing?
 - Please see Section 31 and 33A of The Dog control Act 1996 for details of the process of classification
