## Request for Information - Local Government Official Information and Meetings Act 1987

We refer to your official information request dated Wednesday 19 August 2020 that pertains to the search, in 2020 to date, for locations to meet the cleanfill requirements of Lower Hutt

The information you have requested is set out below:

I have attached two previous responses (to both Councillor Brown and Gabriel Tupou) outlining the anticipated process for identifying a future site. Importantly however, HCC has not yet made a decision about whether it wishes to continue providing this service once the facility at 130 Coast Road closes in 2022. This decision needs to be made before we start identifying specific locations.

I previously expected to present a discussion document to HCC's Corporate Leadership Team (CLT) in August 2020 to seek this initial decision. Due to the number of cleanfill-related enquiries received over the past several months however, I have been unable to advance this discussion as quickly as I would like. I am now aiming to present a paper to CLT in late-September. If CLT decides that the continued provision of a cleanfill is desirable, then I will commence the search for potentially suitable sites. In principle I expect this process will broadly involve:

- 1. CLT provides confirmation that HCC wish to proceed with a site selection process;
- 2. Identification of minimum criteria for a suitable site. These criteria will then be used to populate a longlist of potential sites using GIS technology. My current expectations are that this initial list will capture all sites that could feasibly lend themselves to cleanfill operations and will include sites meeting the following criteria:
  - a. HCC owned;
  - b. Within the city's administrative boundaries; and
  - c. With a minimum site area of 1 ha.
- HCC staff will then review this initial longlist and eliminate sites considered to have fatal flaws (e.g. regional parks, residential sites, lack of road access etc.). This will formulate a shortlist of prospective sites;
- 4. At this point we expect to undertake community consultation to seek the views of HCC residents. This would provide the opportunity to ask questions, express concerns, raise alternative sites or otherwise discuss the proposal with HCC staff;
- 5. The shortlisted sites will then be ranked against scoring criteria to identify a preferred site(s) for further consideration:
- 6. At this stage HCC would undertake necessary site investigations and obtain the necessary approvals to establish a cleanfill on the site. Depending on the location of the prospective site this may require a second round of targeted consultation with nearby landowners / occupiers;

- 7. Once the approvals have been obtained, HCC would look to undertake any site improvements necessary for the site to function. This could involve upgrading accessways, erosion and sediment controls or ground works; and
- 8. Once improvements are made the site would then be ready for operation. The expectation is that this work would be completed prior to the 19 June 2022 to allow for a seamless transition for contractors operating within HCC.

I trust that this adequately addresses your enquiry and I am happy to continue discussions through future CLG meetings.
