\$100,000 in 2019/20 towards events and activities:

- Community Mural
 - Allocated \$16,000
 - Local artists and community working together to create a cohesive artwork which represents, Naenae past, present and future.
- Naenae Market \$200,
 - Allocated \$20,000
 - To provide financial support for resourcing and promotion of the market for a six month period to see if the event can be grown into an event that financially supports itself. This is an event that if it can grow through more stall holders, variety of stalls and entertainment it provides an opportunity to bring foot traffic to the Naenae Centre that in turn offers potential customers to the local retailers.
- Hillary Court Activation Fund
 - Allocated \$10,000
 - To increase in community led events and activities in and around Hillary Court – not yet open
- After School physical Literacy and play programme - Pukutakaro
 - Allocated \$46,000
 - Pukutakaro is an afterschool programme which creates a safe environment for our tamariki (5-13) to explore active play and develop physical literacy. Pukutakaro presents an alternative model of sporting involvement for those tamariki who, for whatever reason, have been excluded from the traditional sport system.
- Remaining \$8,000 – yet to be determined

\$200,000 for Naenae CBD Activation:

- Allocated \$50,000 to Hutt Valley Chamber of Commerce pilot programmes over the next six months.
- \$150,000 – yet to be determined.
