Thank you for your email inquiry dated 23 June 2020 to Hutt City Council.

This letter provides information requested in regards to; "....the cost to date, consultant fees, legal, land acquisition and salaries of staff that have worked on this project... (The RiverLink Project)"

You further clarified your request on 8 July 2020 to include; "...all costs associated with the RiverLink Project".

Your request has been considered under the provisions of the Official Information Act 1982 (the Act).

To provide context to your request, the RiverLink Project was formed between Greater Wellington Regional Council, Waka Kotahi (NZ transport Agency), and the Hutt City Council; to deliver increased flood protection, Melling transport improvements, and central city growth as described by the Making Places Strategy.

Hutt City Council is responsible for the delivery of the Making Places objectives of, turning the central city to face and connect with the river, development of a riverside promenade, enabling good inner city development, enhancing public space, provision of a pedestrian bridge over the river, and adjusting the local street, car parking, cycling, and pedestrian networks to suit.

From August 2016 to 1 August 2020 Hutt City Council spent a total of \$6,292,208.72 Excluding GST on RiverLink. This is made up of the following;

1.	Professional fees, legal fees, & costs Preliminary Design.	= \$1,125,771.52
2.	Professional fees, legal fees, & costs RiverLink Phase One.	= \$1,266,437.20
3.	Daly Street Properties plus fees & legal fees.	= \$3,900.000.00
4.	HCC TOTAL COST	= \$6,292,208.72

The cost of Council staff time is not provided as the information does not exist. Staff time on projects is not recorded and salaries are allocated annually across multiple projects. Accordingly, this part of your request has been declined under section 17(e) of the Act.
