In 2018/19 66.5% was user pays funded, this was below the funding ratio required by Council of 70%-80% cost recoverable and fees were increased.

In 2019/20 74% was user pays funded. This is within the funding ratio.

Note: the shortfall is funded by ratepayers and this includes all other animal management



UNREGISTERED DOGS

Owners are advised that dogs are legally required to be registered by the age of 3 months. Registration is due by 1 July of each year. Ownership of an unregistered dog renders the owner liable for an infringement notice for \$300.

Section 42(2) of the Dog Control Act 1996 states that

"If a territorial authority has reasonable grounds to believe that a person has failed to comply with subsection (1), a dog control officer or dog ranger may:

- (a) seize and impound the dog: and
- (b) for the purposes of paragraph (a), enter, at any reasonable time, any land or premises (except a dwellinghouse) occupied by the owner of the dog."

CHANGE OF ADDRESS/OWNERSHIP

Both the previous owner and new owner of a dog are required to notify the Council, in writing, within 14 days of a change of ownership and new address. Failure to do so may render the dog owner liable for an infringement notice for \$100.

RESPONSIBLE DOG OWNER STATUS

Responsible Dog Owner (RDO) status is granted only to those owners who meet the requirements described in the Hutt City Council Dog Control Policy.

To retain RDO status owners must register their dog on time each year. Owners who pay registration fees after 31 July will lose their RDO status and will not be eligible to reapply for a minimum of one registration year.

PRIVACY STATEMENT

The Council may hold, use and disclose personal information you have provided:

- · to communicate with you about dog registration;
- · to enable us to maintain our records; and
- · to carry out our regulatory functions.

You have the right under the Privacy Act 1993 to access, and have corrected, information held by the Council, which is at **30 Laings Road**, Lower Hutt 5010 (telephone **570 6666**).

The Dog Control Act 1996 requires the Council to record the dog owner's date of birth.

DOG OWNER RESPONSIBILITIES

The obligations of dog owners are contained in Section 5 of the Dog Control Act 1996. These are:

- (1) (a) To ensure that the dog is registered in accordance with this Act, and that all relevant territorial authorities are promptly notified of any change of address or ownership of the dog:
 - (b) To ensure that the dog is kept under control at all times:
 - (c) To ensure that the dog receives proper care and attention and is supplied with proper and sufficient food, water and shelter:
 - (d) To ensure that the dog receives adequate exercise:
 - (e) To take all reasonable steps to ensure that the dog does not cause a nuisance to any other person, whether by persistent and loud barking or howling or by any other means:
 - (f) To take all reasonable steps to ensure that the dog does not injure, endanger, intimidate, or otherwise cause distress to any person:
 - (g) To take all reasonable steps to ensure that the dog does not injure, endanger, or cause distress to any stock, poultry, domestic animal, or protected wildlife:
 - (h) To take all reasonable steps to ensure that the dog does not damage or endanger any property belonging to any other person:
 - (i) To comply with the requirements of this Act and of all regulations and bylaws made under this Act.
- (2) Nothing in this Act limits the obligations of any owner of a dog to comply with the requirements of any other Act or of any regulations or bylaws regulating the control, keeping, and treatment of dogs.

HUTT CITY COUNCIL BYLAW 2015 AND HUTT CITY DOG POLICY

Owners are reminded of the provisions of the Hutt City Council Bylaw 2015 – http://www.huttcity.govt.nz/services/animals/owning-a-dog which among other things requires dogs to be leashed while in public places, owners must remove faeces where their dog defecates in a public place or on land other than that occupied by the owner, a licence is required for more than two dogs on the same premises, exercise areas are designated and entry to some public places prohibited. There is seasonal prohibition of dogs from some of the beaches. These beaches are signposted.
