



## Participant rate by wards




## Participant numbers by wards






## Participant response by suburb





# Do you support the proposal that that Hutt City Council comprise of a Mayor and 13 Councilors?



134 respondents (36%) support the proposal

116 respondents (31%) oppose

90 (24%) are neutral

30 (9%) participants left no response.



# Do you support the proposal that that Hutt City Council comprise of a Mayor and 13 Councilors?

#### **Support**


- General sentiment in supportive comments making reference to accounting for our growing population
- 22 people (16%) who supported the proposal shared comments that they were in favour of adding a Māori Ward

#### **Oppose**

- 38 people (32%) who opposed this proposal shared comments related to not wanting a Māori Ward Councillor
- 31 responses (26%) in opposition to this question shared comments related to retaining community boards



# Do you support the proposal that councillors be elected under a mixed system of representation of 5 city ward councillors, 7 councillors from the general ward and 1 Māori councillor?



132 respondents (36%) support the proposal

139 respondents (38%) oppose

75 (20%) are neutral

24 (6%)participants left no response



# Do you support the proposal that councillors be elected under a mixed system of representation of 5 city ward councillors, 7 councillors from the general ward and 1 Māori councillor?

#### **Support**

- fair and democratic
- 19 respondents (14%) shared comments supporting adding a Māori Ward


### **Oppose**

- 38 (27%) don't agree with establishing a Māori Ward
- 18 (13%) of those who opposed made comments regarding retaining community boards

There were an even number of comments regarding a preference for having a 'Ward only' or 'At-Large' system

139 respondents (38%) support the proposal

131 respondents (35%) oppose

**75 (20%) are neutral** 

25 (7%) participants left no response.



# Do you support the proposal for the five General Wards?

#### Support


 General sentiment in comments from those who support the proposal indicate that changes to the Northern, Eastern and Central Wards make sense

#### **Oppose**

- View that the Harbour Ward has a number of distinct communities and Wainuiomata Ward is too big and they should have 2 Councillors each
- 20 comments (15%) from those who opposed this proposal focused on the loss of community boards



# Do you support the proposal that the there be no community boards in Te Awa Kairangi ki Tai Lower Hutt and the three existing Community Boards?



79 respondents (21%) support the proposal

18 (5%) are neutral

268 respondents (72%) oppose

5 (2%) participants left no response.



# Do you support the proposal that the there be no community boards in Te Awa Kairangi ki Tai Lower Hutt and the three exisiting Community Boards

#### **Support**

- 10 comments (12%) noted that community boards are ineffective, offer little value or don't represent all views in their communities
- 13 comments (16%) highlighted a lack of equality across the city based on the current model where three suburbs have additional representation

#### **Oppose**

- General assertion that community Boards are a valuable asset for representing, supporting and advocating for local issues, particularly the unique communities they currently operate in
- 80 submissions (29%) made specific comments on the value of service provided by the Eastbourne Community Board
- 41 submissions (15%) suggested extending Community Boards to all wards



### Other comments and feedback

- Five submissions suggested extending Harbour Ward to include the area south of Burdan's Gate to Pencarrow lighthouse
- 15 submissions suggested including Korokoro in the Western ward



## **Appeals and Objections**

- the appeals and objection period will run from 12 September 2024 to
  12 October 2024
- If hearings are required, a provisional date of 26 November 2024 has been allocated by the Local Government Commission
- Any agreed changes as a result of the appeals process will be implemented in preparation for the local body elections in October 2025
