## Hutt City Council Public Drainage Network Connection requirements and details

- Most connections will be associated with an approved Building or Resource Consent from Hutt City Council.
- If these works require access to a neighbouring property, you must provide the neighbour's permission in writing with this application.
- The connection to public drainage network must be carried out by a Certified drainlayer.
- Once your application is approved, you must arrange for the Certified drainlayer to carry out the works.
- All work must comply with the Regional Standard for Water Services.
- The excavation must be large enough to allow the connection work to be done safely and must comply with the requirements of the Health and Safety at Work Act 2015 and all relevant regulations, including the Health and Safety in Employment Regulations 1995 and the Health and Safety at Work (General Risk and Workplace Management) Regulations 2016.
- You must provide Wellington Water at least 48 hours notice to test, inspect and approve the connection.
- The excavation exposing the connection must remain open for Wellington Water's inspection and approval.
- All new drainage must be recorded by the drainlayer. Measurements (from at least two fixed points, able to be located again in the future) relating to the position of the new connection are to be recorded and included with the as-built documentation/plans.
