This is an application by Akash Bangarh for a renewal of a manager's certificate.

The application was duly notified and no opposition or notice of desire to be heard has been received. Accordingly I deal with the matter on the papers.

Pursuant to the Sale and Supply of Alcohol Act 2012, the application by Akash for a renewal of a manager's certificate is **granted**.

I am satisfied as to the matters to which we must have regard as set out in s.224 of the Act.

STATUTORY CRITERIA

Sale and Supply of Alcohol Act 2012

224 Application for renewal of manager's certificates

- (1) The holder of a manager's certificate may apply in accordance with this section for the renewal of the certificate.
- (2) Every application for the renewal of a manager's certificate must
 - (a) be filed with
 - (i) the licensing committee for the district in which the applicant is presently employed as a manager; or
 - (ii) if the applicant is no longer employed as a manager, the licensing committee for the district in which the applicant is residing; and
 - (b) be made before the date of the expiry of the certificate;

and

- (c) be made in the prescribed form and manner; and
- (d) contain the prescribed particulars; and
- (e) be accompanied by the prescribed fee.

REASONS FOR THE DECISION

I have considered this application on the basis of the reports received from Police and an Inspector appointed under the Act who do not oppose the issue of the application. In addition no objections have been raised.

DECISION

The District Licensing Committee Chair, acting pursuant to the Sale and Supply Of Alcohol Act 2012 **grants** an application by Akash Bangarh for a renewal of a manager's certificate.

The holder of this manager's certificate has provided an undertaking stating that he will not use the manager's certificate unless a current work visa is held. Should he be issued a further work visa, a copy will be provided to the NZ Police and the District Licensing Committee. The applicant has also provided an undertaking stating that he will limit the use of this Manager's Certificate to NDK Hospitality Limited t/a The Jolly Pub & Kitchen, 8 Evans Street, Stokes Valley, Lower Hutt.

The certificate expires on 9 June 2025 unless again renewed.
