# Striking the right balance

2023-24 Rates



In this year's draft Annual Plan, we're continuing to focus on getting the basics right for our city, but the cost of delivering the basics has gone up substantially. This means it's just not possible for us to do everything we planned to do within the budget we set previously.

We're heading into the 2023-24 financial year with high inflation, supply chain challenges, and workforce shortages. This isn't a unique problem for Lower Hutt – these are global challenges. These also have an impact on everyone in our community, and we're really conscious of that.

In our draft Annual Plan for 2023-24, we've looked at our whole budget and made a number of decisions to manage these cost challenges:

- · Reducing budgets and deferring projects
- · Increasing fees and charges
- · Increasing some budgets

#### **Rates increase**

After making savings within our budgets and deferring projects, we're proposing to increase rates revenue by 9.9% (after growth) from 1 July 2023. This is an increase from our planned rates rise of 5.9% (after growth) for this year.

We have also recently undergone our three yearly property revaluation process to update our record of property values in Lower Hutt. This change, along with the proposed rates increase, means an average increase of \$5.02 per week per household, or an average increase of \$261 per year.

Investment in three waters infrastructure makes up about half (\$131) of the average \$261 rise. The remaining \$130 covers cost increases for all the other services provided (including transport, parks, community facilities, rubbish, recycling etc).

## Wastewater and water supply targeted rates

This draft Annual Plan proposes more investment in three waters than previously planned. This means increases to the targeted rate for 2023-24, to fund the work programme for wastewater and water supply. These are presented per rating unit, or separately used or inhabitable part (SUIP).
