I have been going over my notes and submission points and, having heard and read the submission by Iain Dawe from the GWRC, I realise that he has covered all the points I would have made in terms of sea level rise and the potential for managed retreat of the Eastbourne/Bays area when the access road fails because of sea level rise/inundation/land subsidence. My main point was that application of Change 56 to this area should be deferred until the Council had better information available to it. I feel that point has been made and that I cannot add anything useful.

I am sorry that I was not able to make this call in time for someone else to take my place. Please give my apologies to the panel for any inconvenience.
