Mana Whenua role in the process	The partnership is described more clearly in the policy and the process section shows engagement with Mana Whenua is the first and most important step in the process when a location needs naming/renaming irrespective of who raises the request or whether or not the site is of significant importance
Specific mechanisms for Mana Whenua engagement on naming/renaming	The mechanisms are being discussed by Mana Whenua. The Port Nicholson Block Settlement Trust Naming Committee is likely to be the mechanism for the Tenths Trusts, Te Rūnanga o Te Āti Awa, Taranaki Whānui, and our two Mana Whenua marae. There is ongoing conversation about the makeup of that committee. There will be a separate mechanism for Ngāti Toa.
The practicalities of engaging with the Mana Whenua entities about names in areas across Te Awa Kairangi ki Tai	Officers and Mana Whenua will develop a work instruction to guide the engagement on naming areas in Te Awa Kairangi ki Tai. This instruction will include considering the interests of Mana Whenua entities in specific geographical areas.
Prioritising Te Reo Māori names	The policy has a preference for Te Reo Māori names
Explanation of Te Awa Kairangi ki Tai in the policy	An explanation of the name and context has been added to the definition section of the policy



Aronga | Purpose and Scope

 Sets out the process for deciding the official names of roads, open spaces, Council facilities including Council buildings and parts of buildings/facilities, and rooms in Council buildings, suburbs, localities and subdivisions/developments.



Kaupapa hukihuki | Proposed policy

- reflects the importance of Council's relationship with Mana Whenua;
- prioritises the use of Te Reo Māori names;
- ensures that the process of determining appropriate names takes account of the views of Mana Whenua, interested parties, and communities;
- ensures that names are appropriate and provide ease of identification for the Council, public, and key services;
- ensures that names reflect the city's unique identity, culture, and environment.
- applies a consistent and transparent best practice approach, for accurate and efficient administration and communication.



Tukanga | Process

1. Engagement with Mana Whenua when naming or renaming is proposed;

2. Officers and Community Boards will assess proposals against the 6 criteria in the policy



Paearu | Criteria

Priority	Criteria	
First	An appropriate Te Reo name	
Second	 Where an appropriate name is already in common use. Telling a story about the history of the feature, by acknowledging people and ensuring that women and under-represented groups are acknowledged. Te Reo names are encouraged where appropriate. Where a specific theme is associated with a location and is considered to be 	
	appropriate for new names.	
Third	 Reflects the local landscape, topographical features, or flora/fauna. The preference is for appropriate Te Reo names to be used Aligns with adjacent street/suburb/open space names, e.g. naming a new reserve the same as a nearby road.
