The actual distance (from the construction site) to the closest residences is more than 45 metres, and the main equipment generating vibrations are vibratory rollers and excavators; therefore, the level of vibrations received at the foundation of nearby houses was unlikely to exceed 1.0mm/S PPV threshold level that can result in complaints, based on the BS Standard. On the 11th May the Environmental Health Officer contacted the consent holder and requested that they adopt noise mitigation measures regarded as the best practical option under section 16 of the Resource Management Act, to reduce loud impact noise.
