These do not have to be filed with this return but must be available to support enquiries about the return if

- 0.4.0 Donations can be monetary or physical goods or services supplied or a combination thereof.

  Donations to a candidate of labour only or donations of goods and services that have a fair market value of \$300 or less do not have to be declared – see \$103A of the LEA 2001.

  Candidates must declare donations from each contributor that exceed \$1500 in value. Where a contributor has made donations in instalments that sum to more than \$1500 in value, each contributing donation needs to be listed in Part A and the aggregated sum shown.
