## Resource Management Act 1991: Section 95E and s176 Approval to undertake works in association with Te Karearea Business Park – Benmore Crescent and Manor Park Road Upgrades

KiwiRail Holdings Limited (KiwiRail) has reviewed the resource consent application and plans for the works in association with Te Karearea Business Park – Benmore Crescent and Manor Park Road Upgrades prepared by Spencer Holmes on behalf of Rosco Industrial. The works involve upgrades to Manor Park Road and the intersection of Benmore Crescent with Manor Park Road and include upgrades to the level crossing at Manor Park Road.

The subject site shares parts of its eastern boundary with the Wairarapa Line.

Please note that this letter constitutes an Affected Party Approval pursuant to s95E of the RMA for the proposed works and also constitutes requiring authority approval pursuant to s176(1)(b) of the RMA for the works that are to take place within the railway corridor.





## Additional approvals prior to construction

Prior to construction works commencing additional non-RMA approvals will be required from KiwiRail to enable the works to proceed. These include engineering approval from the KiwiRail Engineering Team and may also include a Deed of Grant for any physical infrastructure related to the development that needs to be located in the corridor, and a Lease may be required for the planting on KiwiRail land. The KiwiRail Grants team can be contacted with regard to a Deed of Grant at grants@kiwirail.co.nz and the KiwiRail Leasing Team can be contacted with regard to a lease at leasing@kiwirail.co.nz.

In addition to the above approvals, a 'permit to enter' is required to undertake works in the rail corridor. The permit can be obtained from the National Permit Office on: <a href="mailto:nationalpermits@kiwirail.co.nz">nationalpermits@kiwirail.co.nz</a>.

## **Expiry of this approval**

This approval will expire two years from the date of this letter unless resource consent has been obtained. This approval will lapse at that date unless prior agreement has been obtained from KiwiRail.
