### **KEY OBJECTIVES OF THE BRIEFING**

The purpose is to discuss Council's proposed submissions on two water services bills to central government and obtain feedback before the draft submission is finalised.

### INTRODUCTION

The focus is on the Water Services Legislation Bill. Officers have not prepared a submission for the Water Services Economic Regulation and Consumer Protection Bill, but could potentially support submissions by Taituara, Local Government New Zealand (LGNZ) or other councils. Wellington Water Limited is delivering its own submission.

Officers have looked at the Water Services Legislation Bill submissions from Taituara and LGNZ and has been working with other councils when drafting its submission.

  Entity: Most councils are expected to submit against this. The requirement will involve
  considerable work and will take Hutt City Council twelve months to have systems in place. It
  is likely to cause public confusion over accountability for Three Waters.
- **Slide 7 Submission point powers of entry:** This point is not mentioned in submissions by other organisations. To gain entry to private property Council would potentially have a lengthy process to undergo before it carries out renewals or maintenance.
- Slide 8 Powers of entry wastewater example.
- **Slide 9 Other submission points:** Other submission points Council wants to emphasise are based on the following rationale:
  - Water is fundamental to achieving community wellbeing
  - Council is the primary organisation undertaking growth plans and placemaking in its city. It's growth and planning are reliant on three waters services

### QUESTIONS AND DISCUSSION POINTS

- The voice of Mana Whenua will be captured in Council's submission.
- The exclusion of social, environmental, cultural and economic well beings does not align with Taumata Arowai aspirations.

Officers will provide a draft submission on the Water Services Legislation Bill to the Council meeting on 23 February 2023. Council's extension on its submission expires on 24 February 2023.
