

In February, the District Plan Review Committee approved the purpose of the Spatial Plan:

- To provide strategic direction for urban growth over the next 30 years.
- To **bring together strategic planning** for land use, transport, three-waters infrastructure, community facilities, parks & open spaces, climate adaptation and business & economy **into a single document**.
- To identify an integrated **plan of action** to accommodate population growth.
- To identify improvements in existing neighbourhoods to address deficits.
- To update and replace the Urban Growth Strategy 2012-32.



In July, the District Plan Review Committee:

- Approved the **general direction** of the Spatial Plan;
- Instructed officers to prepare a Draft Spatial Plan for community engagement;
- Approve the approach to community engagement, i.e.
 Draft Spatial Plan and Proposed District Plan to be consulted on at the same time;
- Approved changing the name of the document from "Spatial Plan" to "Sustainable Growth Strategy 2025-2055".







Since July, we have:

- Incorporated feedback from Councillors.
- Engaged with Mana Whenua and incorporated of their input into relevant parts of the Strategy.
- Expanded the Climate Change section.
- Added Te Reo Māori titles.
- Added the Mayor's acknowledgement.

Te Awa Kairangi ki Tai Lower Hutt

Rautaki Whakatipu Sustainable Growth Strategy 2025-2055



- Moved the full analysis of opportunities and constraints to an appendix.
- Improved maps and graphic design.



Mana Whenua feedback (1):

- Importance of papakāinga.
- Incorporate matauranga Māori into environmental planning.
- Include Mana Whenua knowledge in water-related planning.
- **Wastewater** being released in our waterways is not acceptable to Mana Whenua.
- **Opportunity to innovate** in upgrades, e.g., planting along awa, supporting healthier habitats.

• Align with aspirations from **Te Mahere Wai** (Mana Whenua whaitua implementation plan).



Mana Whenua feedback (2):

- Make the Cultural Identity section broader, with a dedicated section on Mana Whenua.
- Utilise **cultural narratives** and knowledge in development and planning.
- Recognise that many **sites of significance** to Māori have been built over and urbanised.
- Support the revitalisation of local Marae as community spaces.
- Acknowledge the aspirations of Mana Whenua around

improving economic and social development.

• Add Mana Whenua as **partners** in relevant actions.



Chapter 1

He whakatakinga Introduction

Introduces the purpose and strategic context of the Strategy.



National Policy Statement for Urban Development (NPS-UD)

Aims to make sure that New Zealand's towns and cities are well-functioning urban environments that meet the changing needs of our diverse communities.



Regional Future Development Strategy

A statutory document required under the NPS-UD, which sets out a long-term plan to ensure a 'well functioning' urban environment, showing where growth will be, in what form, and what infrastructure is needed to support that growth.



Sustainable Growth Strategy 2025-2055

Guides how we want our city to change over the next 30 years.

Intends to inform decisionmaking and investment decisions by Council, government and private sector.



Other Plans and Strategies

Various local and regional plans and strategies inform the Growth Strategy.



Lower Hutt Long Term Plan 2024-2034

Hutt City Council's priorities and projects for the next 10 years inform the Growth Strategy.



Action	Action Description	Status	Council	Other Agency	
1. Support Te Wai Takamori o Te Awa Kairangi project	This project includes improved flood protection, the relocation of the Melling train station, a new pedestrian bridge across the river linking the station to the city centre, a new interchange on State Highway 2 and improvements to local streets and riverside park. These initiatives, plus the redevelopment of surplus land for apartments and businesses, will help regenerate the city centre.	Underway (funded)	City Delivery	GWRC, NZTA and Mana Whenua	
2. Improve wastewater capacity in Hutt Central through the IAF wastewater upgrades	The wastewater project will deliver a new bypass, redirecting existing wastewater flow (from Hutt Central catchment) to the Western Hills trunk main. This strategic diversion will alleviate strain on the current infrastructure, thereby unlocking additional housing capacity and reducing the risk of overflow discharge in this area.	Underway (funded)	City Delivery		
3. Reduce flood risk in Hutt Central through the IAF stormwater upgrades	The existing stormwater infrastructure in the Opahu Stream catchment is currently operating at full capacity. The objective of the stormwater project is to expand capacity within the trunk network.	Underway (funded)	City Delivery
