Questions and discussion points

- Three micromobility projects, where differing levels of work have been done, are looking to be paused and put forward into the next National Land Transport Programme (NLTP) 2024/27. This will lessen the number of disruptions in these areas due to other projects/ works.
- In response to a question regarding the work being done in Petone and the possible pressure of the Riverlink project being worked on simultaneously, the Head of Transport advised that they're putting together their NLTP programme and being mindful of traffic flows and main arterials to avoid added disruption. He said they do not want to be doing wholesale work on the same streets Riverlink works are happening.
- The Head of Transport explained how some businesses have raised concerns about the City Centre Walking and Cycling project route, and how this could impact access, traffic flow, and concerns about people cycling through/ past major entry and exit points. Officers are seeking direction from Council whether to proceed with the design work in this area or hold off until the next NLTP and risk losing funding.
- The Head of Transport explained that officers will go back and engage more with businesses.
- A member raised concerns about the cycle path connecting to Riverlink through Taita Drive and Harcourt Werry Drive due to a busy intersection.
 The Head of Transport explained that speed reviews and traffic calming measures are currently being done to consider safety.
- The Naenae proposal is still under consultation with further discussions to be had with the Naenae Community advisory group.

Next steps

- Bring proposals to Council for formal approval.
- Consult with the Naenae community advisory group about proposed cycle path and design.
- Finalise business case and design for Waterloo to City Centre cycleway as one package and submit for funding for the 2024/27 NLTP programme.
- NLTP programme to be finalised in the next three months.
