# RE: Hutt City Council Proposed District Plan – Formal written notice of Clause 4 consultation with requiring authorities

Thank you for your recent letter notifying Transpower New Zealand Limited ("Transpower") of the anticipated notification of the City of Lower Hutt Proposed District Plan ("PDP") in early 2025.

Transpower has three existing designations in the operative City of Lower Hutt District Plan, summarised below:

- TPNZ 1, G1, Electricity Substation (Haywards)
- TPNZ 2, C3 D3, Electricity Substation (Melling)
- TPNZ 3, C6 D6, Electricity Substation (Gracefield)

Pursuant to Schedule 1 (Clause 4) of the Resource Management Act 1991, Transpower gives notice that the above designations are still required to be included in the PDP. The designations are not subject to any conditions and Transpower seeks no modifications to them.

In accordance with the National Planning Standards (the Planning Standards) the rollover notice is set out following Table 14 of the Planning Standards, which is a mandatory direction. Attached to this letter are the designation maps for the three designations.
