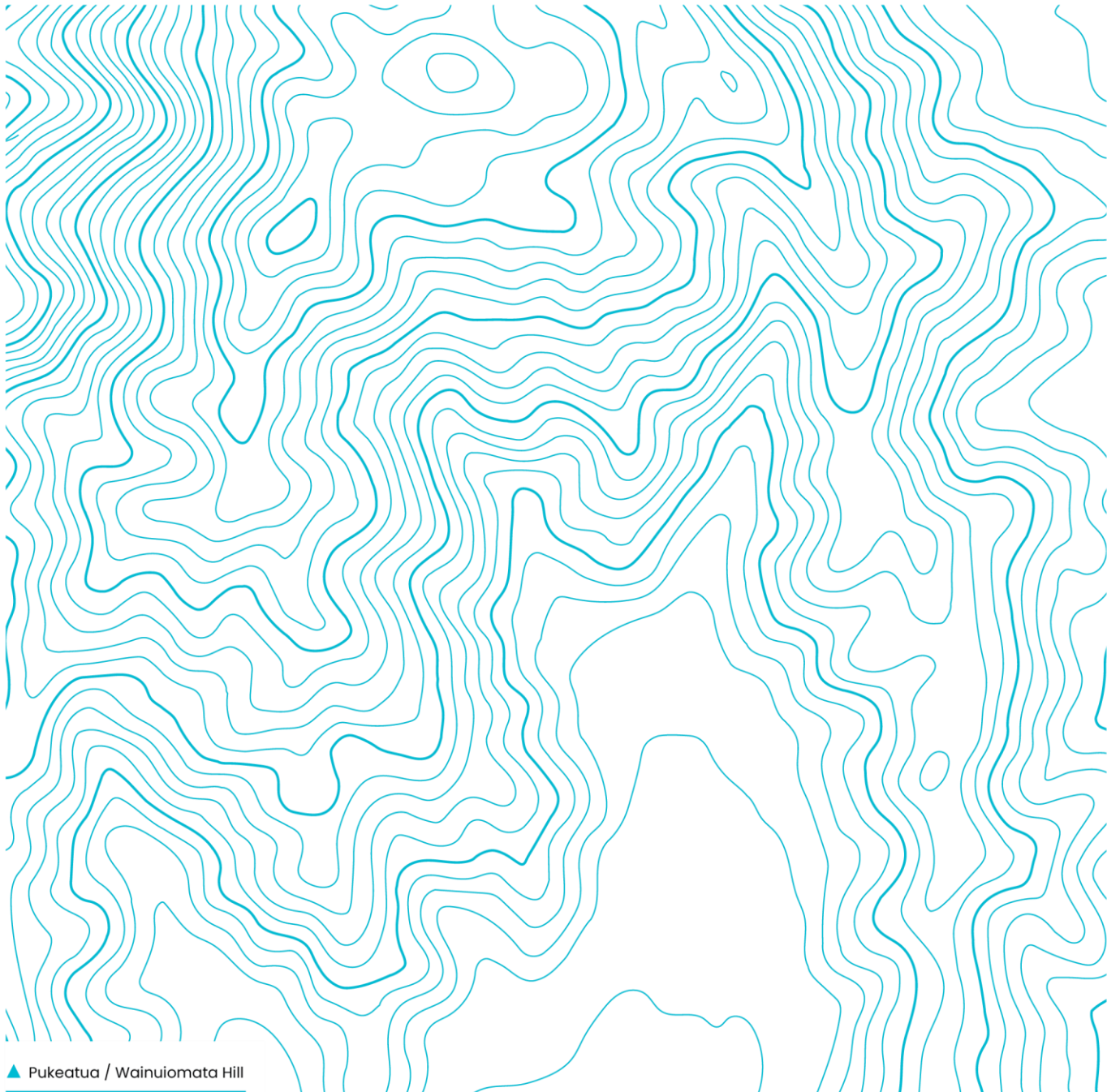

Privacy Statement

A submission on the Proposed District Plan must include the submitter's name, and an address for service (preferably email, but it is possible to use a postal address). All information included in submissions, including name and address for service, will be provided to other submitters and published on Hutt City Council's website. Paper copies may also be made available. Hutt City Council is required to collect and publish this information to carry out its functions under the Resource Management Act 1991 and to enable others to take part in the district plan process. The Council, other submitters, and the Environment Court may need to contact submitters during this process.

While the Council will retain all information provided in a submission in secure council systems, all contact details will be removed from any documents published on Council's website once the district plan process is complete. However, name and the contents of submissions will still appear in these documents.

You have the right to ask for a copy of any personal information we hold about you, and to ask for it to be corrected if you think it is wrong. If you'd like to ask for a copy of your information, or to have it corrected, please contact us at contact@huttcity.govt.nz, call 04-570-6666, or write to us at Private Bag 31912, Lower Hutt 5040.
