- 1. This is a submission from THE BODY CORPORATE OF 220 222 JACKSON STREET PETONE C/- GEOFFREY MITCHELL WANE (Body Corporate Member authorised to act on its behalf on this matter) on the Proposed Lower Hutt District Plan 2025.

- 3. I could not gain an advantage in trade competition through this submission.
- 4. The specific provisions of the proposal that my submission relates to, my submission on those provisions, and the decisions I seek are shown in the below table. I also seek all further, alternative, necessary, or consequential relief as may be necessary to fully achieve the relief sought in this submission.
- 5. I wish to be heard in support of my submission.
- 6. If others make a similar submission, I will consider presenting a joint case with them at the hearing.

Introduction

- 7. 220 -222 Jackson St has a popular history in Petone. From 1878, it was originally George and George Drapers.
- 8. The current building was built in c1921 of concrete and reinforcing steel.
- 9. With the closure of major manufacturing plants in Petone, most shops were closing and the population was low. The concept of re-developing 220 224 Jackson into apartments to draw people back into the Petone centre. The intention was to retain as much as the original exterior as possible and to ensure overall design was in keeping with the building's original style.
- 10. The developers' arhitect (Perry Architects) consulted with their own heritage architects and with the council's then historical consultant Ian Bowman. The recessed balcony was designed in keeping with the period. The marionette balconies on its left and right were a compromise on full-sized balconies. The blocked off shop windows above the retained verandah were restored to original. Shop bay entrances were restored.
- 11. Everything was done to keep the original historical look, while ensuring the building was a lot safer.
- 12. The assessment of heritage buildings undertaken in 2023 -24 used different criteria to that included in the proposed plan. One of the assessor architects acknowledges this.
- 13. 220 222 ended up some how being classified as a non-contributing building.
- 14. I have spoken with Michael Kelly (one of the assessors) who has discussed the classification informally with his colleague. Thery have reached a provisional consideration that 220 222 should be classified as a "contributing building". But they say that consideration of anything other than a "heritage building" classification was not part of their work.
- 15. It is not known whose part of whose work it was/is.
- 16. However it is submitted that 220 222 Jackson St be re-classified as a "contributing building" and that the classification criteria be reviewed for consistency.
