Submission on the Proposed Lower Hutt District Plan

- 1. This is a submission by Virginia Saunderson on the Proposed Lower Hutt District Plan 2025.

Introduction

7. In my opinion it is vitally important to preserve areas of historical significance for all people. Unfortunately for Māori this has been made much more difficult due to the loss and degradation of their land in areas where they traditionally lived, gathered resources, and practiced traditional customs. This has made it more difficult for them to pass on traditional knowledge and history through generations. It is important to preserve these sites for future generations and the presevation of history.

There are examples where developers and mana whenua have worked together to achieve both parties' aims and I believe the inclusion of Sites and Areas of Significance to Māori in the Lower Hutt District Plan will allow that sort of outcome and ensure no further loss of access to these sites for mana whenua.

I believe that The Treaty of Waitangi promised the protection of taonga (sites where food and resources were gathered and traditions were practiced) and we should honour that promise. Including the SASMs in the district plan allows the Council to work in partnership with iwi in the spirit of The Treaty of Waitangi.

My understanding of the purpose of the SASMs is to encourage developers to work with mana whenua to acknowledge the significance of the site to Māori through design principles, signage or naming, but this is not compulsory and will not stifle development. It will also protect archaeological material that might be unearthed in the development process and alerts potential developers of the likelihood of finding archaeological material on the site so they can develop a process and plan for that eventuality.

Finally mana whenua will not have any rights or access to privately owned properties under the proposed SASM provisions.

I am a pākehā property owner in Eastbourne and I am dismayed by the misinformation being spread about this proposal, and wholeheartedly support the SASM provision in the Distric Plan.

Comment

- 8. I support the inclusion of the Sites and Areas of Significance to Māori (SASM's) chapter in the proposed Lower Hutt District Plan 2025. The key issue with the current plan is that it does not include all sites and areas of significance to Māori, and this limits the plan's ability to protect these sites
- 9. I believe it is essential that the proposed District Plan identifies and protects sites and areas of significance to Māori, and I am pleased to see the Hutt City Council taking steps to acknowledge and safeguard these important places.
