- 7. This submission is the request for a change to the elevated risk slope assessment for a portion of our property at 133 Park Road Belmont. I am a retired Roading Engineer (in fact for many years I was the Manager of the Road and Traffic Division at Hutt City Council including responsibility for the assessment and remediation of landslips city wide.) Although the rear of the property drops away and the 'elevated risk' slope assessment is valid over the lower (southern) portion, the actual dwelling is located near the front (road boundary) almost on the crest of a ridge with a much gentler slope contour that, in my opinion, is not at all in risk of slope failure. I request that, as is the case with our neighbours at 131 Park Road, the elevated risk zone be redefined clear of the dwelling.
