I also seek all further, alternative, necessary, or consequential relief as may be necessary to fully achieve the relief sought in this submission.

## Introduction

7. I do not oppose St Bernard's being designated in the District Plan as land for educational purposes and I accept that it is an established use of the land however, I

- believe that the designation should include conditions that prevent increased severity of existing adverse environmental effects or new adverse effects.
- 8. My home is in Anderson Grove, and my rear boundary is shared with St Bernard's College.
  - a. The rear of my section and house face northwest. This is important for my environment, and it also has positive flow on effects to the wider environment because:
  - i) On sunny winter days it is not necessary to heat the living area of my house, it is passively heated by the sun. My neighbours have also altered their houses to take advantage of this environmental effect.
  - ii) Being able to passively heat our homes contributes to sustainability for us and also the wider community. It reduces the consumption of electricity and fossil fuels.
  - iii) It is also possible to grow vegetables in our back yards, at least one of my neighbours has a substantial garden producing both vegetables and fruit. I also intend to grow more produce.
  - iv) Privacy is an important aspect of my back garden environment, and I am sure that my neighbours also value this and it currently we are able to socialise in our back gardens without the risk of being observed from the neighbouring property, St Bernard's College.
- 9. Parking is an issue in Anderson Grove and is becoming an issue in other nearby streets. Traffic in the mornings and afternoons is also hazardous. While I accept that traffic related issues have existed for a long time, I believe the designation should at least attempt to prevent them becoming worse.
- 10. Noise, I accept that there will always be noise from a school however, I believe that there should be reasonable controls on the level of noise.
- 11. In summary I want conditions inserted in the designation to protect my and my neighbour's environments from potential increases in adverse effects caused by the operation of St Bernard's College.
- 12. Further it is my understanding that the requiring authority, in this case Ministry of Education, can apply at anytime to alter or remove its designation however, it is not open to landowners who are affected by a designation to apply for the removal or alteration of a designation. Owners of suburban residences are not as well resourced as the Ministry of Education and the main option they would have would be to convince the Hutt City Council that the Council should alter the designation. Accordingly, it is important that conditions that protect the amenities of the wider environment be included when a designation is granted.

- The Ministry of Education's notice of requirement description of the public work proposed is very broad without any conditions, this means that if the designation is granted as applied for absolutely anything for the purpose of education can be done on the site without reference to minor or more than minor adverse environmental effects.
- 13. I also believe that the consultation on the proposed designation is inadequate while it describes briefly what a designation is it does not explain the effect of the St Bernard's College designation on activities on St Bernard's College land. Designations are a technical creation of the Resource Management Act (RMA). The RMA is a mystery to the average New Zealand citizen and even if a person reads the relevant sections of the RMA it is unlikely that they will understand it. Therefore, to validly consult and honour the spirit of consultation I believe that there should be more information provided so that the people who are believed to be affected enough to receive limited notification actually understand how the proposed designation could affect them in the future.
