Introduction:

My submission relates to the effect such proposed changes will have on our future potential to develop the property we own at 56 Miromiro Road being 7,745sqm. We are currently preparing plans to provide future housing options for our children with new builds on this section. In particular we note that the slope assessment overlay applied to our property is not based on a detailed site survey but rather less accurate 'air to ground' radar data.

In the anticipation of future building and subdivision we have completed a detailed topographical survey as of 15/7/2024. This survey details a greater area of existing flat to low gradient areas than is detailed on the council produced overlay. Our submission is that this detailed topographical survey is used to amend the slope assessment overlay as currently applied to our property.
