Introduction

- 10. I'm making a submission in response to the Proposed District Plan change that would see my property at 26 Kowhai Street, Naenae, reclassified as being within a high natural hazard area. I understand such a classification would severally restrict my ability to either subdivide the property or place an additional house/s on the back of the land, as allowed under the current District Plan. I purchased 26 Kowhai Street in 2018 on the basis that the location of the underground services made it feasible to add an additional house/s on the property. I've already added two dwellings to my other Naenae property (7 Sinclair Grove), and I wish to add an additional house/s for people to rent at 26 Kowhai Street.
- 11. In the time I've owned the property I've never seen the land flood, so I'm unsure why it's being considered as being within a high natural hazard area. I therefore think that such a reclassification is an unfair restriction on my ability to add value to my property and to increase the supply of affordable homes for rent in Lower Hutt, so ask that my property is not classified as being within a high natural hazard area.
