## Introduction

7. Given that the only area where the building falls under the categories to be recognised as historically significant is that it is in good condition the building does not have significant historic heritage value and does not need to be protected in the plan. I also believe that the Council has made an error either with the consent (BC210556) or the CCC in that in turning the building into apartments it has not addressed the state of the windows which do not seal and allow drafts and moisture to enter the building. This creates a social and environmental as well as a health issue for the people living in the building. This provision will also impose additional costs to the owners of the building if they want to rectify this issue and may even prevent them from doing so.
