Approval for any major changes to the granted building consent	<ol> <li>Check if any changes been made to the building work</li> <li>Have approval(s) been obtained for the changes to the building work?</li> <li>If approval has not been obtained and the changes affect the building work being inspected, fail the inspection.</li> <li>However, if the changes do not affect the building work being inspected, pass the inspection if all other inspection requirements have been met.</li> </ol>

Items to be checked	Help Text			
Use of building products or building methods that have been banned or have warnings issued	<ol> <li>Check for the use of any building products or building methods that have been banned by MBIE. If used, fail the inspection.</li> <li>Check for the use of any building products or building methods that have had warnings issued by MBIE. If used, check if building code compliance is compromised. If building code compliance is compromised, fail the inspection.</li> </ol>

Construction and demolition hazards	Are protection measures in place as per the building consent?

Items to be checked	Help Text
Construction	Is the pool constructed as per the building consent?
Safety from falling	Have measures for preventing a fall of 1 metre or more from the pool walls been constructed as per the building consent?
Pool water filter	Has a pool water filter been installed as per the building consent?
Discharge for filtered pool water	Does the filtered pool water discharge to an outfall as per the building consent?

Items to be checked	Help Text
Area surrounded by the pool fence	Is the area surrounded by the pool fence as per the building consent?
Height	Is the height of the pool fence or pool wall as per the building consent?
Fence	Has the pool fence been installed as per the building consent?

Location of pool fence	<ul><li>1) Is the pool fence positioned away from climbable objects as per the building consent?</li><li>2) Is the pool fence positioned as per the building consent?</li></ul>

Self-closing device	Have self-closing devices been installed as per the building consent?

Location of gate	Is the gate positioned away from climbable objects as per the building consent?		
Automatic close	Test whether the gate returns automatically to the closed position after use.

Pool safety signage	Have pool safety/warning signs been installed as per the building consent?			
Pet doors				
Items to be checked	Help Text			
Pet door to immediate pool area	Are there any pet doors providing access to the immediate pool area? If yes, fail the inspection.
