3 TRADE WASTE CONSENT FEES (1 JULY 2021)

Category	Fees	Explanation
1 – High risk	\$1,660.00	Dischargers that have a high risk to the sewers, operators or the environment where regular inspections are required.
2 – Moderate risk	\$840.00	Discharges that have a moderate risk to the sewers, operators or the environment, require regular testing, and have high flow rates
3 – Low risk	\$470.00	Dischargers that have a low risk to the sewers, operators or the environment, require regular testing, and have medium flow rates
4 – Minimal risk	\$250.00	This applies to 1 Food premises that have the potential for a high volume and/or high strength discharge 2 Where an inspection showed that the condition of the grease trap was unacceptable 3 Commercial car wash or truck wash pads where there is regular cleansing and no hazardous materials stored on the wash pad 4 Food premises with grease converters
5 – Minimal risk with low flow	\$125.00	This applies mainly to food premises where there is proof of regular cleansing of the grease trap by an approved method or by inspection and where there is a low flow of waste water from the premises. May include premises with grease converters where evidence of adequate maintenance and sink screening has been provided. Small washpads and laundrettes may also be consented in this category
Conditional consent	\$165.00	This fee is in addition to the consent fees and applies when the flow of trade waste exceeds 2L/s (or 5m³ per day) or where a variation from standard conditions is required
Application fee	\$95.00	
Re-inspection fee	\$115.00	
Late payment administration fee	\$100.00	
Transfer additional fee	\$47.50
