## **Approved sites**

- (a) **Cambridge Terrace** whole length of railway berms, excluding areas shown on plan no's 1 to 5 and plan 11 & 11A attached.
- (b) **George Street** (See plan 6) east side, starting at southern end Delaney Park and extending 80m northwards between the fence and the road.
- (c) **Harbourview Road** (See plan 7) south side, starting 15m east from first house on left hand side going uphill from SH2 and extending 60m eastwards.
- (d) High Street whole length, south side of railway berms, excluding area shown on plan 8 attached.
- (e) Major Drive (See plan 9) north side as shown on plan.
- (f) Normandale Road (Signs 1 sq metres only) south side as shown on plan.10
- (g) Oxford Terrace whole length of railway berms, excluding areas shown on plan 11 & 11A attached.
- (h) Parkside Road north side, on grass berm as shown on plan 12.
- (i) **Pharazyn Street** north side, as shown on plan 13.
- (j) **Wainuiomata Road** west side on grass berm as shown on Plan 14 to be visible only to north bound traffic.
- (k) **Wingate Crescent** on any of the grassed island areas north and south of the Wingate Overbridge as shown on Plan 15, not closer than 5m to any kerbline.
- (I) Wingate Roundabout-High Street to Oxford Terrace In grassed island as shown on Plan 16, not closer than 5 or 9 metres behind any kerbline.

## **Conditions**

The following information sheet is designed to assist event organisers in the preparation and placement of temporary signs, excluding commercial advertising.

A list of the Conditions and Approved/Not Approved sites follows:

- 1. Only one sign at each location.
- 2. Sign specification of 1200mm x 900mm maximum.
- 3. That the sign does not obstruct any other signs already in place.
- 4. All signs are to be maintained in a safe, tidy condition and inspected regularly.
- 5. All signs shall be removed within 24 hours of the last showing.
- 6. Signs not to be erected for more than 21 days.
- 7. Extreme care must be taken when digging holes for sign support as underground power, telephone, water and gas services may exist at any depth below the surface.
