I refer to your information request of 30 June 2022 asking for information about the disk golf facility at Hikoikoi Reserve.

We understand that the disk golf infrastructure was installed by the New Zealand Disk Golf Club.

Around September or October 2021, the Hutt City Council's Reserves Asset Manager was approached by the club to install concrete pads. The cost for the concrete pads was around \$9000 and there was a discussion that the club would contribute half the cost, but this arrangement was not followed through with the resignation soon after of the Reserves Asset Manager.

There is no other documentation that shows that Hutt City Council had invested in the disk golf course. The Council does maintain the reserve and keeps that area clean and tidy.
