Request for Information pursuant to the Local Government Official Information and Meetings Act 1987 (LGOIMA)

Thank you for your correspondence of 30 March 2023, in which you have requested information about 'Sovereign Citizen' ideals being referred to as justification for non-payment of rates and other payments to Hutt City Council. Your request has been considered under the LGOIMA.

Hutt City Council has seen Sovereign Citizen ideals (and similar approaches) being mentioned on occasion by its citizens, particularly in relation to payment of parking infringement fines. Our Rates Team does not recall any incidents. We have been unable to locate records of the term 'Sovereign Citizen' being used by our customers, so accordingly we are unable to provide the specific information you have requested.

We have attached one record, this relating to a dog control matter. Some information has been withheld from this record under section 7(2)(a) of the LGOIMA, to protect the privacy of individuals.

Hutt City Council's approach to managing these situations is to continue with the enforcement action. Anecdotally, the teams report no increase in cases noticed by Hutt City Council, nor have there been records of physical threats received.
