**Request for Information – Local Government Official Information and Meetings Act (the Act) 1987**

We refer to your request dated 5 January 2025 for Information. We will answer each of your questions in turn.

**1.Data on local housing demand, including any assessments of homelessness or housing shortages in the area.**

Council's assessments on local housing demand are based on external data provided by Sense Partners. Projections for housing demand and capacity over the next 30 years is available through Council's Housing and Business Development Capacity Assessment: [https://wrlc.org.nz/wp-content/uploads/2024/04/HBA3-CHAPTER-3-Hutt-City\\_16.02.24.pdf](https://wrlc.org.nz/wp-content/uploads/2024/04/HBA3-CHAPTER-3-Hutt-City_16.02.24.pdf). It should be noted that this only deals with future demand, not existing shortages.
