Request for Information – Local Government Official Information and Meetings Act (LGOIMA) 1987

We refer to your official information request dated 5 July 2025 for:

I would like details of dog ownership of dog registration in each of the suburbs the Hutt City Council is responsible for. Details include: suburb, total dogs registered in that suburb, total responsible dog owners (RDO) in each suburb, and what the indicative human population in each suburb is. I have attached an example of Wellington City data (excluding RDO details).

Answer:

In response to your request, please see the table below which provides a breakdown of registered dogs and Responsible Dog Owners (RDOs) by suburb, as at 10 July 2025.

Please note, one entry in the dataset below is listed as "Blank (no suburb)". This reflects records where a suburb was not captured in the database. This may be due to a data entry oversight or because the location is an exception where a suburb cannot be readily assigned.

We do not hold information on the indicative human population by suburb. However, this information is publicly available from Stats NZ, which publishes population data by geographic area. Accordingly, this part of your request is refused under section 17(d) of the LGOIMA, as the information is publicly available.

Population data can be explored using the Stats NZ Geographic Boundary Viewer: <u>Statistics New Zealand</u>.

If you require more specific information than what is available through the Geographic Boundary Viewer, you may wish to contact Stats NZ, which is subject to the Official Information Act 1982 (OIA). You can make an OIA request via their website: Official Information Act (OIA) requests | Stats NZ.
