Request for Information – Local Government Official Information and Meetings Act (LGOIMA) 1987

We refer to your official information request dated **20 July 2026**, seeking information about residential swimming pool building consent statistics within the Council's district.

Specifically, you requested:

"Would your council be able to provide (or point me to) building consent statistics for residential swimming pools issued in your district over the past 3-5 years? Ideally broken down by year and separating new pool installs from alterations/barrier-only consents if that distinction is available in your records. If this isn't something your team holds directly, I'd appreciate being pointed to the right team or public register (e.g. LIM data, consent register, or your building consents team) who could help."
