

# Request for Information pursuant to the Local Government Official Information and Meetings Act 1987 (LGOIMA)

I refer to your correspondence of 13 March 2023 in which you requested the following official information:

"... all information relating to the lifting of the red sticker on 60 Holborn Drive."

Please find attached the material you have requested. We advise that some material has been withheld under the following sections of the LGOIMA:

- 7(2)(a), to maintain the privacy of individuals
- 7(2)(g), for the maintenance of legal privilege
- 7(2)(f)(i), to maintain free and frank expressions of opinion

Information relating to draft versions of the AECOM report are declined under s7(2)(f)(i) of the LGOIMA, which allows withholding of information if it is necessary to maintain the effective conduct of public affairs through the free and frank expression of opinions by or between or to officers in the course of their duty.

The material relating to drafts was produced for the purpose of review and comment by officers and their advisors. It is crucial that both the consultants and staff are not deterred from setting out free and frank opinions in the context of getting to a robust final opinion that can then become public and/or be relied on to make decisions. Although these are skilled and professional consultants, this was an important regulatory decision that needed robust testing before a final position was reached.

As you are aware, a final report from AECOM was produced and provided to you on 29 March 2023.

In our view there are no other considerations that render it desirable, in the public interest, for the withheld information to be released.

You have the right to seek an investigation and review by the Ombudsman of this response. Information about how to make a complaint is available at www.ombudsman.parliament.nz or freephone 0800 802 602.



Thanks for forwarding the report from Ian Brown. The report concludes that the building is not dangerous and is safe to occupy. Before I reconsider the dangerous building notice, I have a question that I request Ian Brown to consider (or to update his report) so that I can understand the reasons for his conclusions.

The last paragraph of the conclusion in the report outlines an understanding that the Council plan to carry out appropriate slope protection works. These works have now been outlined in agreement between Council and yourself. The report does not appear to otherwise address these shotcrete stability works on the slip face. I accordingly seek clarification as to the impact of these works on the report's conclusion that the house is safe to occupy, and in particular:

- 1. any danger from occupation arising from the proposed remedial works to take place on the adjacent slope,
- 2. the impact of house occupation on the proposed works, such as any risks from falls (with no ability to simply fence the slip face while works are ongoing),
- 3. whether the house is safe to occupy now, or only after the completion of the slope stabilisation works.

Once I receive a response to these matters, I will request the Council's engineers Aecom to review the Ian Brown report and advise me. On receipt of that advice from Aecom, I will consider whether the dangerous building notice should remain in place.




I have also included a photo taken recently which shows the physical state of the manhole right beside the slip face. I suspect water could also enter the stormwater trench from here.

I am following up from the email that you forwarded from Derek Kerite at Hutt City Council regarding our report.

We have not been able to review any details of the slope protection works that are proposed by Hutt City Council. You have indicated that it is likely to include an anchored shotcrete face to the slope. That is commonly used in the Wellington region and we have experience with their design and construction.

Mr Kerite requested clarification as to the impact of these works on the report's conclusion that the house is safe to occupy. I will provide a response to each of the points that he has raised, with the qualification that I have not been able to review the detailed design of the proposed work.

1 Danger arising from the proposed remedial works.

Our report shows that the house site has adequate stability under ULS earthquake loading conditions. It is unlikely that the works would lead to any unusual loading on the slope that would be of concern. Other areas of danger could arise from the operations, however they should be managed by appropriate health and safety plans.

2. Impact of house occupation on proposed works.

Again, appropriate health and safety measures should be put in place to manage potential impacts.

3. Whether the house is safe to occupy now.

Our assessment of current stability does not rely on future work that Hutt City Council may carry out. We have concluded that the house is safe to occupy now.

The Council will be obtaining a written report from its geotechnical engineer in the week of 25 July. Based on that report, a further notice or action to address the risk may be necessary. In the meantime, this notice addresses the immediate risk from occupation of the building.

In accordance with section 128(2) of the Building Act 2004, as a result of this notice: No person may:

- a) use or occupy the parts of the buildings listed above; or
- b) permit another person to use or occupy them

Restricted entry is granted under Section 124 (2)(d) for persons carrying out an assessment on behalf of the owner, insurer or Council.

<u>WARNING:</u> Failure to comply with the requirements of this notice is an offence against section 128A of the Building Act 2004. The maximum penalty for an offence against that provision is a

fine not exceeding \$200,000 and, in the case of a continuing offence, a further fine not exceeding \$20,000 for every day or part of a day during which the offence has continued.
