Request for Information pursuant to the Local Government Official Information and Meetings Act 1987 (LGOIMA)

Thank you for your correspondence of 1 May 2023 in which you have requested the following official information:

- For 2020/21, 2021/22 and 2022/23 (to date) broken down by year please provide:
 - Staff sickness absence figures for each department in the Council. Also detail average departmental sickness days against departmental sickness targets.
- For 2020/21, 2021/22 and 2022/23 (to date) broken down by year please provide:
 - Number of resignations within each department in the Council. If you do not collate resignation figures for each department please provide figures for the Council as a whole.

Our response to these questions are provided below.

Sickness absence

Sickleave days taken by staff for the years 2020/21 to 2022/23 (to date) is provided in the attached appendix. Please note that in 20/21, the Transformation & Resources Team existed as a separate team but was then moved into the Office of the Chief Executive Team.

Hutt City Council does not have any 'targets' for sick leave, so your request for that information is refused under section 17(e) of the Act, on the grounds that the document alleged to contain the information requested does not exist.
