All information held by the Council regarding the land at 14 Rata Street, Wainuiomata which is currently occupied by St Claudine Thevenet Primary School.

Relevant background to my request is that the school's hall has not been used and been desolate since 2011 as it requires earthquake strengthening. The hall is actually owned by the Wellington Archdiocese and local parish, Parish of the Holy Spirit.

Part of my request is whether there exists any HCC policy which addresses unused buildings on land within its jurisdiction. Is there a time limit as to when such desolate buildings need to be either brought to a useable standard or demolished noting the health and safety concerns as young children continue to attend the school.

The second part of my request is seeking all correspondence and documents pertaining to this section of land and efforts to bring the school hall back to code since 2011 i.e. engineer's reports, surveyor reports, building consents, certificate of title and property searches etc.

The school has been without a school hall since 2011. Going on 12 years! 200+ kids are crammed into a prefab for assemblies which is surely a health and safety risk. The Archdiocese has not seen the school as a priority and the children and staff have suffered accordingly.
