Request for Information – Local Government Official Information and Meetings Act 1987 (LGOIMA)

We refer to your official information request dated 24 May 2023 for the following:

“... the cost of the installation and monthly power usage for the EV chargers at the back of the war memorial hall in Wainuiomata, as well as any information the Council holds on the usage of these chargers.”

Hutt City Council and Meridian Energy have collaborated to install 38 new electric vehicle (EV) charging stations. This includes the charging station at Wainuiomata Community Hub. The Council has contributed \$830,000 of the total \$1.2 million cost of their installation, with \$370,000 being co-funded by Energy Efficiency and Conservation Authority from the Government's Low Emission Transport Fund.

Installation costs and other information relating specifically to the Wainuiomata EV charging stations is enclosed in the attached document. I am advised that the Wainuiomata Community Hub chargers used 232kW between 23 May 2023 and 12 June 2023.

Some information has been withheld from this material under section 7(2)(a) of the LGOIMA, to protect the privacy of individuals.

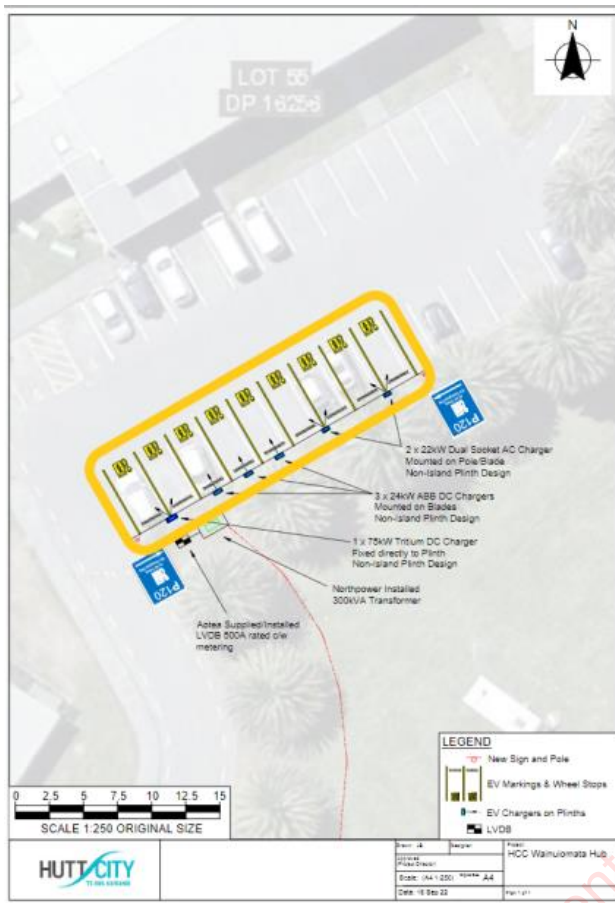

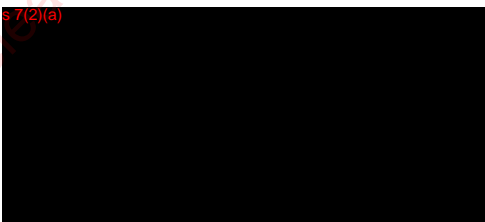
