Request for Information – Local Government Official Information and Meetings Act (LGOIMA) 1987

We refer to your official information request dated 14 September 2025, seeking financial information relating to the current projects listed on Council's "Our Projects" webpage. Specifically, you requested:

- 1. The total budget allocated for each project
- 2. The breakdown of funding sources for each project (e.g. Council funding, central government contributions, Wellington Regional Council, private sector partnerships, grants etc)
- 3. Any documentation or reports that outline how funding is distributed across project phases or components
- 4. How the HCC portion is being funded e.g. cash off balance sheet, loans, rate increases

You also requested that this information be provided in a spreadsheet format, along with links to relevant sources containing financial analysis.

Answer:

On 19 September 2025, we sought clarification from you, noting that Council does not hold the information in the consolidated format described. We asked whether you were seeking information about specific projects or a summary across all listed projects.

You confirmed that your request relates to all projects listed on Council's "Our Projects" webpage and provided a list of 15 projects. You clarified that you are seeking the total estimated capital cost, the portion funded by Council, and the planned commencement and completion dates for each project.

You also provided a spreadsheet template to support collation and indicated you are happy to accept "TBD" where information is not available. You confirmed that phase-by-phase breakdowns are not required.

We advised on 23 September that Council staff would collate the information that is reasonably accessible. As clarification was sought by Council, the statutory timeframe for responding did not reset under section 13(7) of the LGOIMA.

Please refer to the attached spreadsheet titled *LGOIMA – Capital Spend Summary for Council Projects (2025–26)*. This document provides the total estimated capital cost, the portion funded by Council, and the planned commencement and completion dates for each project listed on Council's "Our Projects" webpage.

Please note that all details provided are estimates, excluding any revenue offsets from associated asset sales, and may be subject to change. In some cases, while the information exists, it is not held in a format that is readily accessible and would require substantial collation or analysis to extract. As such, it could not be obtained within the time available to respond to your request. For example:

- For the Wainuiomata Shared Path, Council can confirm NZTA subsidised the project (between 51% - 70%) but an accurate breakdown was unable to be obtained in a timely manner.
- For **Micromobility and other cycleway projects**, funding already received could not be confirmed in a timely manner. The project has now been delayed due to uncertainty around future funding, which was previously assumed at 51%.

These instances are marked in Column D, Rows 9 and 11 of the spreadsheet.

Please also note that the Sportsground Improvements project is a ten-year, \$10 million programme covering a range of sportsgrounds. Some upgrades were completed in the last financial year, with further work planned over the next nine years.

Where information is not available, we have used "TBD" to indicate that the data is either not held or not yet confirmed.
