Parking Services issued 838 infringement notices on Sydney Street, Petone from 01/01/2021 – 15/02/2024.

All applicable consent to private parking allocation to commercial real estate on Sydney Street Petone.

The council holds no information hold related to encroachment licences (consent to private parking allocation) granted along Sydney Street. Therefore, we are refusing this part of your request under section 17(e) of the Act, as the information requested does not exist.

Any official standpoint of Hutt City Council off appropriate blockages to pedestrian highways and plans on how to mitigate them.

When these issues occur, Council engineers can visit a location and review how they can improve pedestrian access. This may include but not limited to painting a designated walkway.
