- *All emails between department staff and board members of KWS including Peggy Luke Ngaheke from January 1 2020 until May 31 2023 – particularly if they relate to Ali Hamlin-Paenga and personal relationships between Hutt City Council and KWS"*

On 11 July 2023, we advised you that the timeframes for responding to your information request were extended. The revised data

Appendix 1 – Section 7(2) LGOIMA withholding grounds

(2) Subject to [sections 6, 8](#), and [17](#), this section applies if, and only if, the withholding of the information is necessary to—

(a) protect the privacy of natural persons, including that of deceased natural persons; or

(b) protect information where the making available of the information—

(i) would disclose a trade secret; or

(ii) would be likely unreasonably to prejudice the commercial position of the person who supplied or who is the subject of the information; or

(ba) in the case only of an application for a resource consent, or water conservation order, or a requirement for a designation or heritage order, under the [Resource Management Act 1991](#), to avoid serious offence to tikanga Maori, or to avoid the disclosure of the location of waahi tapu; or

(c) protect information which is subject to an obligation of confidence or which any person has been or could be compelled to provide under the authority of any enactment, where the making available of the information—

(i) would be likely to prejudice the supply of similar information, or information from the same source, and it is in the public interest that such information should continue to be supplied; or

(ii) would be likely otherwise to damage the public interest; or

(d) avoid prejudice to measures protecting the health or safety of members of the public; or

(e) avoid prejudice to measures that prevent or mitigate material loss to members of the public; or

(f) maintain the effective conduct of public affairs through—

(i) the free and frank expression of opinions by or between or to members or officers or employees of any local authority, or any persons to whom [section 2\(5\)](#) applies, in the course of their duty; or

(ii) the protection of such members, officers, employees, and persons from improper pressure or harassment; or

(g) maintain legal professional privilege; or

(h) enable any local authority holding the information to carry out, without prejudice or disadvantage, commercial activities; or

(i) enable any local authority holding the information to carry on, without prejudice or disadvantage, negotiations (including commercial and industrial negotiations); or

(j) prevent the disclosure or use of official information for improper gain or improper advantage.

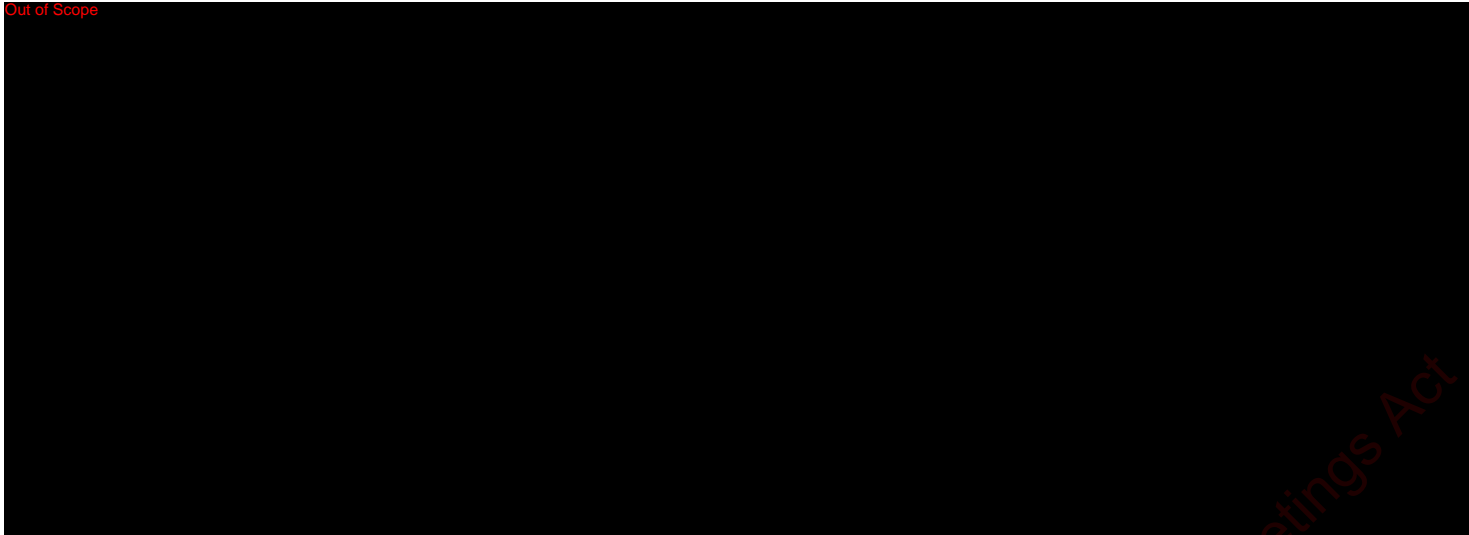

"Hutt City Council are in the process of negotiating our Infrastructure Acceleration Fund (IAF) bid with Kāinga Ora to provide infrastructure to unlock housing development capacity within a large chunk of the valley floor surrounding Hutt Central. Without this infrastructure, no new housing development will be able to occur in this area, but with it we have an opportunity to take a strategic view of the delivery of high-quality housing that supports thriving communities in Hutt Central and beyond.

As part of our commitment to the IAF, we're developing a strategic framework and governance layer with associated mechanisms to support sustainable and socially beneficial housing at scale in this area and we're looking to partner with key developers to formalise your intent to develop and our commitment to providing support to enable Hutt City to thrive in the years ahead. At this meeting, we'll provide an overview of that framework, and will be inviting you to enter into a formal agreement with Kāinga Ora and Hutt City Council to collaborate in achieving world-leading outcomes for Hutt Central.

Given the nature of the negotiations, this is a one-stop shop. The agreements must be finalised by July 27th at the latest, so this will be a practical session focused on formalising our commitments so that we can incorporate you as part of the final IAF submission due in August.

As Council, we are committed to providing supportive mechanisms and measures that enables nationally significant development outcomes. We welcome and encourage your participation in this process to help us all contribute to a thriving Hutt City."

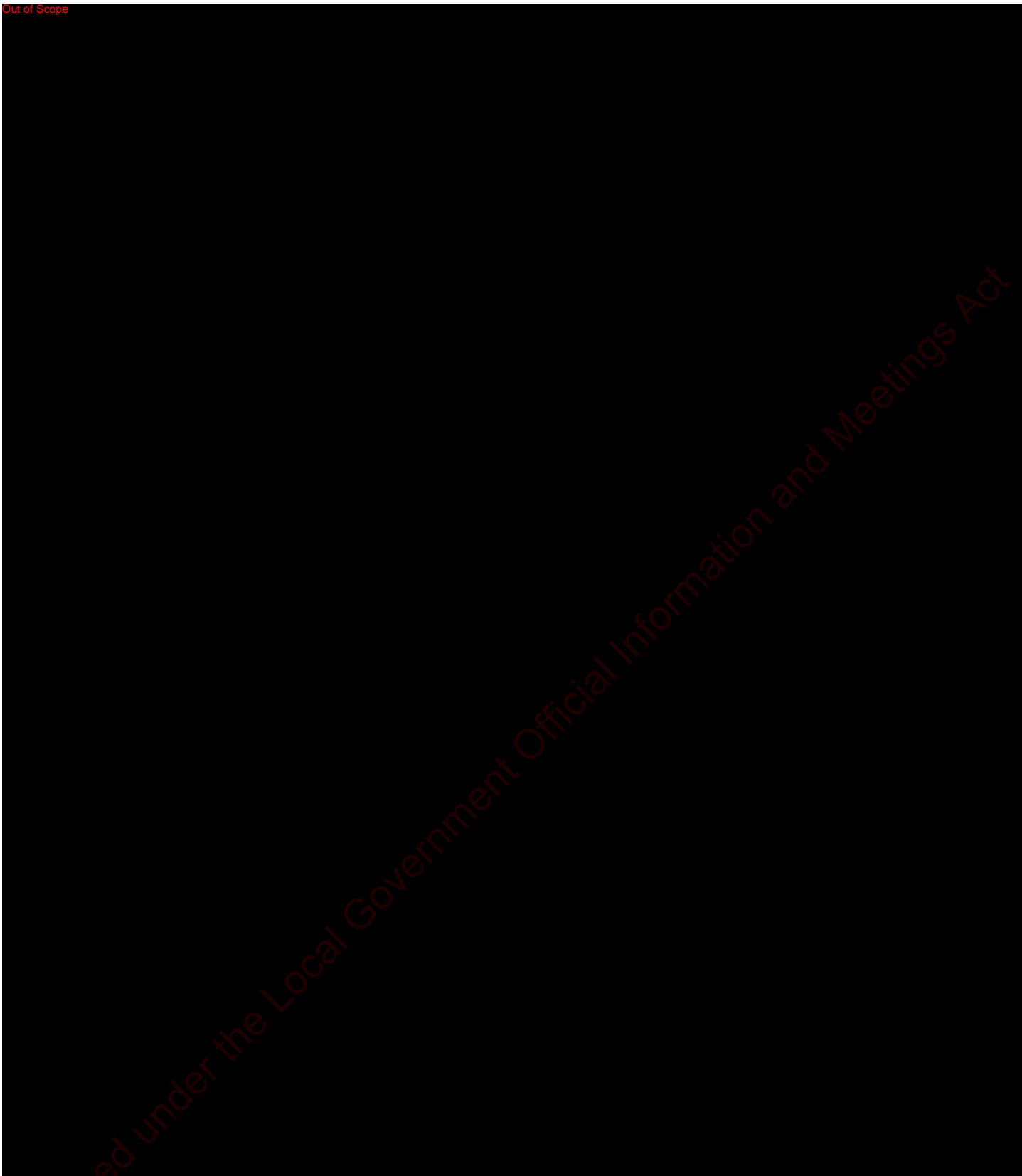

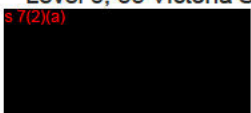

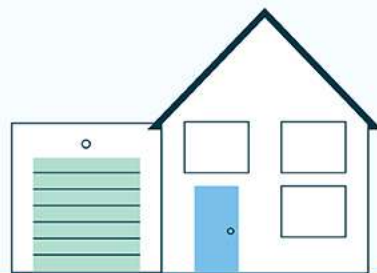

The policy context



The housing response deals with very complex policy circumstances. These have compounded over the last few years with changes to legislation and standards, and their interaction with the pandemic.

This includes the Residential Tenancy Act and introduction of Health Housing Standards.

While these were welcomed by the sector, there were unintended consequences of the policy implementation.

Our response: networks and frameworks

In addition to housing supply, housing quality is a major issue. Hutt City Council is a member of the Wellington Region Healthy Housing Group.



Our organisation was also the first Council to include building performance information on properties' Land Information Memoranda (LIMs).

Another initiative is Tuanui – Wainuiomata Healthy Homes for All'. The Year One goal of the Tuanui project is to ensure 40 of the most unhealthy homes in Wainuiomata are deep retrofitted to a healthy standard, at the same time as whānau are supported to access to wrap around support in other key areas.

Our response: Homelessness Strategy



Hutt City Council is working in an innovative way to combat homelessness in our city. Housing and homelessness is complex, and the sector is heavily networked.

We have formed partnerships with three Kaupapa Partners – Tuatahi Centre, Takiri Mai Te Ata, and Community Law Wellington and Hutt Valley.

Through Covid, we learnt that we need to utilise the trusted networks in our communities to affect change and assist whānau. Letting them navigate this in their own way is the best outcome for our city and whānau.

Subject: Vaccination of Essential Workers

Kia ora tatou,

Jo and I have been working with Kahungunu Whanau Services and Te Atiawa to see if we can stand up a mobile vaccination centre for essential workers.

We are still unforming this but my initial thoughts in order for us to do this we will need support in these areas:

- Site identification – Alannah could you loop in directly with Ali (in this email) to organise a time to do a reky of our sites
- Workers – maybe Team Manaakitanga who can help with setting up the site, admin and also running the site with the health provider (all people working on the site must be double jabbed)
- Developing and funnelling our list essential workers / frontline staff (including contractors) to the team (Jon, Alannah, John and Marcus – will need those names and numbers of our contractors who are deemed essential)
- We may also want to be the central point to gather and administer the essential workers list within the valley - this will require us to be the main point of contact feeding all the essential workers through to the health provider. This will require some comms from our end to connect with all the worksites in the valley with essential workers (supermarket etc).
- There will also need to be a connect in with EOC to help in co-ordination

I will organise a meeting with Kahungunu Whanau Services and Te Atiawa teams on Monday so we can all co-ordinate this together.
